

# 2024 SIFMA C&L Society DE&I Advocate Award Application

#### What is this award?

First awarded in 2022, the SIFMA C&L Society Diversity, Equity & Inclusion (DE&I) Advocate Award celebrates legal and compliance professionals who have demonstrated an exceptional commitment to building creative solutions that address DE&I inequities in the financial services industry and ensures the next generation of leaders reflects our diverse society.

The award is presented annually by the <u>SIFMA Compliance & Legal Society</u> at its <u>Annual Seminar</u>. The next Annual Seminar will be held in Orlando, Florida on March 17- 20, 2024, and is focused on individuals who are disrupting the status quo in the development, implementation and support of DE&I initiatives.

Nominees should have demonstrated measurable success in supporting and encouraging the inclusion of women, minorities, persons with disabilities and/or persons of differing sexual orientation and gender identities.

## Who is eligible?

Any legal or compliance professional working for a financial services firm, outside counsel, or vendor that supports the industry may be nominated. The nominee must be able to demonstrate tangible and sustainable results. SIFMA C&L Executive Committee members are not eligible for nomination.

Nominees will be assessed in the following categories:

- Innovation of DE&I ideas
- Thought leadership in the legal and compliance sector of the financial services Industry
- Leadership and promotion of diverse teams
- Leadership through creating an environment that eliminates barriers to communication and encourages everyone's contribution
- Hiring, retention and promotion of diverse candidates



#### Nomination

Who? An individual may be nominated by another in the industry or submit a self-nomination.

How? By completing the application form in this document and submitting it to <a href="mailto:clsociety@sifma.org">clsociety@sifma.org</a> by Tuesday, October 24, 2023.

The submitted nomination should include:

- 1. Name and contact information of nominee
- 2. Name of person submitting the nominee (if applicable)
- 3. Name of employer
- 4. Nominee's resume or LinkedIn profile (if resume is not available)
- 5. Statement of nominee's approach to solving DE&I-related issues (philosophy)
- 6. Detailed and expansive description of instance(s) of innovative, unique or creative approach to tackling a DE&I initiative
  - a. Scope of the project
  - b. Participants or systems involved
  - c. Results (quantitative and qualitative). This information is critical in the Committee's assessment of submitted applications.
  - d. Impact statement or press related to the initiative to demonstrate tangible results
- 7. A reference statement in support of the nominee from an individual other than the person making the nomination

Note: SIFMA membership and participation in SIFMA C&L conferences is not a requirement, but will be a factor taken into consideration in the review process.

### Selection

The SIFMA C&L Annual Seminar DE&I sub-committee will review all intake forms and select 3-5 finalists.

The recipient will be notified before November 21, 2023 so that they will be able to arrange travel to appear at the SIFMA C&L Annual Seminar, Marcy 17-20, in Orlando. The recipient will be asked to maintain confidentiality.

#### Award

The award will be presented at the SIFMA C&L Annual Seminar, to be held in Orlando, Florida on March 17-20, 2024.
